#### THOUGHTS FROM YOUR PRESIDENT . . . . .


I'll have to hurry and get this article written before Norma gets home! She can't understand why I have to clutter up her kitchen with my typewriter and my other little projects.

# 1988 CONVENTION

JUNE 23 - 24 - 25 - 26, 1988

Start making your plans now to attend the 1988 N.C.C. Convention. 1988 brings the 15th Birthday of the National Cambridge Collectors, Inc.! We will also be celebrating the 6th anniversary of the Museum opening; our 13th annual Antique Show & Sale; as well as our 15th annual Convention. How fast the time passes, when one is having fun!

Special events will be held to celebrate our anniversaries, including a Birthday Party on Friday night, June 24th. Don't procrastinate as June will be here sooner than you think. Make plans now to be in Cambridge for your Convention. If you don't attend, you will be sorry you missed the event of the year!

As previously announced, the theme of this year's convention is "Cambridge and the 1950s." This includes not only the years 1950-54, but also the reopen period. Programs, including the Saturday morning breakfast program, will be presented, dealing with the theme, and in addition the Display Room (at the Shenandoah Inn) will also be devoted to Cambridge glass from the 1950s.

To make the Display Room a success, we will need glass from you, the membership attending the Convention. Share your collection with others. Especially needed are pieces from the Cambridge Square, Cascade, Corinth, and Sonata lines. We would also like to put together an outstanding display of Cambridge Arms, so please, loan your Cambridge Arms items for use in the Display Room.

In addition we need examples of all colors, patterns, etchings, cuttings, and decorations done during the 1950s. Particularly desirable would be items from the Milk Glass, Ebon and Mardi Gras lines. To see what we need, turn to the N.C.C. Reprints of the 1949-53 and 1956-58 Catalogs, as well as the "Colors in Cambridge Glass" book. Anything shown in the first two books, as well as any piece in 1950s colors can be used in this display. As usual, display glass must be made available by Friday, June 24th, and except for unusual conditions, cannot be removed until Sunday afternoon. If you do have exceptional items you would like to show, but cannot meet these requirements, let me know, and special arrangements can be made. Watch the next issue of the CRYSTAL BALL for further information regarding Display Room glass.

As previously announced, our Banquet speaker will be Mr. Frank Fenton, recently retired President of the Fenton Art Glass Company. Mr. Fenton's talk will cover glass companies in the Ohio Valley, as well as some of the people, associated with the glass industry, he has known over the years.

Following our Saturday morning breakfast, George Fogg and Frank Maloney will present a program dealing with the Convention theme. Both George and Frank are long time members of N.C.C., and have attended many conventions. For those of you who are aware of the program they presented at last year's Heisey Convention, this will not be a repeat. To quote George and Frank, "Lest we perpetuate our new nicknames of 'Abbott and Costello,' we will not be offering elaborate productions as afore mentioned. We do aspire to a program that will be in good taste, informative and educational, factual but perhaps tonguein-cheek, and most important -- involving participation by some of the convention goers." What will it be? Come and find out!

We are retaining the extra day, Thursday, June 23rd and, as last year, convention activities on this day will be limited to Registration, Programs, and in the evening the Convention Chairman's Reception. The latter event was well received last year and will once again be very informal, consisting of a cash bar, chips and dip, and a place to sit and "gab" with old and new friends. As before, this will be included as part of the Convention Package at no additional charge. An added feature Thursday night will be a Silent Auction. All of the programs presented on Thursday will be repeated later during the weekend.

Due to a lack of participation, the glass factory tours held in previous years will not take place this year. Directions to the various factories will be made available to those individuals desiring to visit them.

An activity, in the planning stage, is to have work parties at the Museum Storage building during the days preceding the Convention. There is much work to be done with the molds

In June of 1949 the Cambridge Glass Company issued a new catalog and, so far as it is known today, it was the first catalog to be issued by the company since January 1940. The original issue consisted of 148 pages and, during the following months and years (beginning in August 1949), supplemental pages were issued, with the last being added sometime in 1953.

Late in 1953 or early in 1954, catalog type material was circulated showing the Milk Glass and Ebon lines. In 1978 the National Cambridge Collectors published a reprint of this catalog, including the pages showing the Milk Glass and Ebon lines. This article is based on information found in this reprint, along with the associated price lists that have become available

The original 1949 Cambridge catalog contained two pages captioned "Vases," and on these pages were shown eighteen vases, none of which were new that year. (See next two pages for reprints of these catalog pages.)

Eleven of these vases, #274, #278, #279, #1309, #1237, #1238, #1299, #1239, #6004 8", #6004 6", and #1236, were in the Cambridge line, at the latest, by 1937 and were first discussed in my previous two articles on Vases.

According to the 1949 price list, #274, #278, #279, #1237, #1238, and #6004 (both sizes) were, at that time, available in crystal, amber and amethyst; while #1236 and #1239 were being offered in amber and amethyst only. The remaining two vases in this group, #1309 and #1299, were being produced solely in crystal.

By the time the October 1953 price list was issued, only #274, #278, #1237, 1238, and the two sizes of #6004 remained in production and these were listed as being made in crystal.

In addition to the colors just described, vases #6004 (both sizes), #1237, #1238, #274, #278, and #1309 were, as of June 1949, also being manufactured in crown tuscan; however, in October 1953 no vases were listed as being made in this color.

In August 1949, two new colors, emerald and mandarin gold, were introduced and sometime during the following months production of ebony and carmen resumed. Thus, in September 1950 we find the #1237 vase listed as being available in ebony while #6004 (both sizes) and #1238 were being offered in emerald and mandarin gold. At the same time, the 6" version of #6004 was being produced in carmen as was #1237, both with crystal foot and in the case of the #1237, a crystal stem.

The Pristine line was introduced in the late 1930s and six of the vases shown in the 1949 catalog were from this line. Exactly when each was added to the line remains unknown, but was probably before their appearance on a catalog page. The P.580 8" flip vase appears in the January 1940 catalog, the only one of the six to do so. Pristine #575, #565, #572 and #568 are first shown on a supplemental page to the 1940 catalog that is dated June 1941; while the page showing P.563 for the first time probably dates to August 1942.

June 1949 saw this group of Pristine line vases being made only in crystal. By the fall of 1950, after the introduction of emerald and mandarin gold and the resumption of ebony production, we find the P.575 cornucopia (also listed as part of the Corinth line) being made in all three colors; while the P.572 vase was listed in emerald and mandarin gold.


Pristine vases #563, #565, #568, #572, and #575 continued to be in the Cambridge line when the October 1953 price list was issued. However, by then, production was limited to crystal.

The remaining vase from these two pages is the #1066 Ivy Ball. This #1066 line was introduced in 1931 but exactly when the ivy ball went into production remains to be determined. The first known appearance of the ivy ball on a Cambridge catalog page occurred in June 1941. Eight years later, in June 1949, it was being offered with a crystal, amber or amethyst bowl with crystal stem and foot.

By September 1950, this vase was also being offered in emerald and mandarin gold (bowl, stem and foot in color), as well as with a crystal ball with ebony stem and foot. In addition, the #1066 ivy ball was at this time also being made with a carmen ball and crystal stem and foot.









In addition to the vases just described, three additional ones appeared in the original 1949 catalog and these were from the Cascade line: the #4000/573; the #4000/574 oval (a flared version of the #573); and the #4000/235 5"



Initially, these three vases were produced only in crystal, but after the introduction of emerald and mandarin gold, the #573 became available in these two colors as well. By the fall of 1953, none of the Cascade vases remained in production.

During the years 1949-53 many of the vases shown on the two 1949 catalog pages captioned "Vases", were available etched and engraved, as well as plain. During these years the etchings Rosepoint, Candlelight, Chantilly, Diane, Elaine, Portia, Wildflower, Roselyn, Daffodil and Magnolia appeared on one or more of these vases. Roselyn was available on #274, #278, #1238 and #1237; while Daffodil came only on the 8" #6004 and #278, as did Magnolia.

The #278 11" footed vase was used in conjunction with several engravings, including: Achilles; Adonis; and Cambridge Rose, as well as others. The reader is referred to the NCC 1949-53 Reprint for additional information regarding other etchings and engravings.

In addition to etchings and engravings, several




vases were also decorated, during this period, with gold decorations. The #274 and #1309 vases will be found with D/460 Wedding Band; while #278 comes with D/1063 Talisman Rose and D/Woodlily. The #274 will also be found with D/1063 Talisman Rose and the P.604 bud vase was decorated with D/Woodlily.

on two vases, the 8" P.604 and #278.

The October 1953 price list contained a list-

ing for D/1066 Columbine, gold encrusted, on six items which included the 8" #6004 vase. The same price list page also had the gold decoration D/Butterfly available on five items, four of which were vases - both the 6" and 8" #6004, #274 and #278, with the fifth item being the P.306 candy box. At this time, I have no other information about these two decorations. (Editor's Note: See page 16 for photo of the gold encrusted D/1066 Columbine decoration on a Pristine cream and sugar.)

With the reintroduction of ebony and carmen, as well as the introduction of emerald and



#309 and #310 came only in mandarin gold and emerald.




The latter four vases had been in and out of the Cambridge line for many years and the basic shapes appear in several of the major lines, while the Pristine #569 was originally in production by June 1941. In addition, the Pristine #604 8" bud vase was put back into production between June 1949 and September 1950; it, however, was made only in crystal.

With the introduction, in December 1951, of the Cambridge Square line, came seven additional vases, four of which used blown tops from other lines or numbers combined with the Square line foot. The other three, #3797/90/91/92 were unique to the line (see page 8). All seven were listed on the October 1953 price list. It is doubtful any of the seven Cambridge Square line vases were ever made in colors other than ebon and crystal.

The final vases from the years 1949-53 are the two from the Heirloom line, #5000/77 fan vase and the #5000/78 footed vase (see page 8). Both vases first appeared in 1926, in different sizes, when the line was first brought out under the name Centennial. During the 1950s, as part of the Heirloom line, these

# CONSTITUTION

#### ARTICLE I - NAME

Section 1 The name of this organization shall be the National Cambridge Collectors, Inc., operating as a non-profit organization under charter granted by the state of Ohio.

#### **ARTICLE II - OBJECTIVES**

Section 1 The members of this organization shall meet together regularly, for the purpose of acquiring a broader knowledge of glassware manufactured by the Cambridge Glass Company in Cambridge, Ohio (1901-1954) and through instruction, discussion and study, actively promote the preservation and collecting of Cambridge Glass.

Section 2 The primary objective of this organization is to establish and maintain a permanent museum in Cambridge, Ohio (Guernsey County) for displaying and studying of Cambridge Glass. The organization will operate on a non-profit basis and all monies realized will be applied to this end.

#### **ARTICLE III - MEMBERSHIP**

Section 1 There shall be two kinds of membership, namely: voting and honorary.

Section 2 Voting Membership. Any person, age 12 or over, upon payment of the prescribed yearly dues is eligible to become a voting member of this organization. Other qualifications shall be as stated in the by-laws.

Section 3 Honorary Membership. Any person who has distinguished himself in an unusual and praiseworthy manner in promoting the objectives of this organization may be elected to honorary membership. Honorary members shall have the privilege of attending all meetings of the organization, but shall not be required to pay dues, or be permitted to vote or hold elective office, and they shall have no interest in any funds or property of the organization.

Section 4 No territorial limits shall be established for the organization and membership is open to all interested persons.

#### ARTICLE IV - MEETING AND FISCAL YEAR

Section 1 Regular meetings shall be held as provided in the by-laws.

Section 2 The annual meeting shall be held as provided in the by-laws.

Section 3 The fiscal year shall begin the first day of January each year.

#### **ARTICLE V - OFFICERS**

Section 1 The officers of this organization shall be a President, one Vice-President, a Secretary and a Treasurer elected from the Board of Directors by the Board of Directors. All officers shall hold office for one year, or until their successors are elected and qualified.

#### **ARTICLE VI - BOARD OF DIRECTORS**

Section 1 The Board of Directors shall consist of 12 Directors elected by the voting members of the organization. Terms of office are to be as provided in the by-laws.

Section 2 To be eligible to serve on the Board of Directors, a person shall be at least 21 years of age.

Section 3 The Board of Directors shall be the governing body of the organization and shall have power to make such regulation and take such action, not inconsistent with the Constitution and By-laws as, in its judgement, may be necessary for the welfare of the organization. The decisions of the Board in all organization matters shall be final, subject only to appeal to the voting membership of the organization.

#### **ARTICLE VII - SURRENDER OF CHARTER**

Section 1 If this organization deems it desirable, by unanimous vote of the active voting membership, to terminate operation of this organization, all assets, records and monies shall be turned over to the Ohio State Historical Society with the stipulation that such be used only for the study and preservation of Cambridge Glass. In the event the Ohio State Historical Society cannot comply with the above statement, it shall be turned over to the Smithsonian Institute to be used at it's discretion.

#### **ARTICLE VIII - AMENDMENT OF CONSTITUTION**

Section 1 This constitution may be amended by a majority vote of the active members in good standing, present at the annual meeting of the organization, upon proposal by a voting member in good standing sixty days prior to the annual meeting, provided written notice of such proposed amendment shall have been given to members at least ten days prior to the annual meeting.

#### ARTICLE IX - ADOPTION OF THIS CONSTITUTION AND BY-LAWS

This Constitution shall take effect and be in force upon its adoption.

# **BY-LAWS**

#### **ARTICLE I - MEETINGS**

Section 1 Regular Meetings. The regular meetings of the organization shall be held during the months of February, June, August, and November at such time and place as the Board of Directors shall designate.

Section 2 Annual Meetings. The annual meeting shall be held in June for the installation of elected directors, the presentation of annual reports and transaction of other business. The term of directors shall officially begin at the close of business of the annual meeting. Charter directors shall hold office until their respective terms end, as per Article VII, Section 4 of the by-

Section 3 Special Meetings. Special meetings of the organization may be called by the President or by a majority of the Board of Directors upon regular written notice to the Secretary at least five days in advance of said meeting.

Section 4 Quorum. The majority of the active members in good standing present shall contitute a quorum at any meeting of the organization.

Section 5 Rules of Order. Parliamentary procedure in all meetings of the organization, Board of Directors, and Committees shall be in accordance with the latest revised Robert's Rules of Order if not inconsistent with the By-Laws.

#### **ARTICLE II - DUTIES OF OFFICERS**

Section 1 President. The President shall appoint all Committees, shall preside at all meetings of the organization and the Board of Directors and shall perform such other duties as ordinarily pertain to such office. The President shall be ex-officion member of all committees except the nominating committee. He shall, immediately upon taking office, appoint a sergeant-at-arms.

In the event a vacancy exists in the office of President, the Vice-President shall assume the office and title of President during the unexpired term of the President. The President shall furnish bond in the amount determined by the Board of Directors, the cost of which bond shall be paid by the organization.

Section 2 Vice-President. The Vice-President shall have the duty of familiarizing himself with all organization affairs. He shall work under and in cooperation with the President and shall preside at meetings in the absence of the President

Section 3 Secretary. It shall be the duty of the Secretary to keep the official record of all members, voting and honorary, provide verification of voting members as required, record the attendance at meetings of the organization, record and preserve the minutes of such meetings, make the required reports, and perform such other duties as customarily pertain to such office.

Section 4 Treasurer. It shall be the duty of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to his office. He shall collect all dues and funds of the organization and deposit them in bank or depository named by the Board of Directors. Upon his retirement from office, he shall turn over to his successor or to the President, all funds, books and accounts or any other organization property in his possession. The Treasurer shall furnish bond in an amount determined by the Board of Directors, the cost of which bond shall be paid by the organization.

Section 5 Salary of Officers. All the officers shall serve without compensation.

#### ARTICLE III - BOARD OF DIRECTORS

Section 1 Meetings. The President shall be Chairman of the Board. He shall call regular meetings of the Board at least quarterly. He shall call a special meeting within five days after receiving a written request from three or more board members.

Section 2 Functions. (a) The Board shall be responsible for the appropriation of all funds of the organization and shall. through the President or other duly authorized member of the Board, approve all vouchers before payment by the Treasurer. It shall designate the bank or depository in Guernsey County, Onio for funds of the organization, approve all investments of funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. It shall receive and approve Budget and the annual audit of the financial transactions of the organization (b) It shall pass on all projects recommended by the Project committee, which must be approved by a two-thirds vote of the entire Board. (c) It shall pass upon all grievances, defaults and complaints by or against a member, and may take such action as it deems appropriate on behalf of or against such member. It may, for good cause, declare an office vacant, upon two-thirds vote of the entire Board. (d) It may fill vacancies that occur during the year. The President shall appoint, and the Board confirm by a 2/3 vote of those in attendance, a member to fill any vacancy occurring. Said appointee shall serve for the balance of the term being vacated.

Section 3 Quorum. A majority of the members of the Board shall constitute a quorum.

Section 4 Resignation of Board Members. All Associations from the Board, except for those covered under Article X, shall be made in writing to the President.

#### **ARTICLE IV - APPOINTED OFFICERS**

Section 1 Sergeant-at-Arms. The President, immediately upon taking office, shall appoint a Sergeant-at-Arms. It shall be the duty of the Sergeant-at-Arms to preserve order at all times and perform such other duties as ordinarily pertain to this office.

#### ARTICLE V - COMMITTEES

Section 1 The President shall appoint the following standing committees: (1) Membership, (2) Project, (3) Program and Entertainment, (4) Budget and Finance, (5) Publicity, (6) Convention, (7) Study Group Advisory, and (8) By-Laws.

Section 2 Special Committees. In addition to standing committees, there shall be appointed by the President, such special committees as the President and/or the Board of Directors may deem necessary.

#### **ARTICLE VI - DUTIES OF COMMITTEES**

Section 1 Membership. This committee shall promote activities designed to increase membership and shall perform such additional duties as specified by the Secretary in maintaining the records of membership.

Section 2 Projects. This committee shall devise and consider suitable and appropriate projects and shall devise ways and means whereby definite interpretation of the aims and objectives of the organization shall be given expression. It shall take cognizance of all matters of civic or similar nature and recommendations of the Project Committee shall constitute the basis for consideration of all projects of the organization.

Adoption of a project shall require a two-thirds vote of the entire Board of Directors.

Section 3 Program and Entertainment. This committee shall arrange and have charge of all programs for the regular meetings of the organization. They shall also have charge of all social functions of the organization, as may be directed by the Board of Directors.

Section 4 Budget and Finance Committee. This committee shall prepare a budget of the estimated income and expenses of the association for the year. In the month of May, each year, the Finance Committee shall cause an audit of the books to be made, and such statement shall be read to the organization at its annual meeting.

Section 5 Publicity. Publicity Committee shall be responsible for supplying notices concerning the organization meetings to the news media, and further, shall disseminate all interesting information furnished them by officers of the organization, chairmen of various committees. They shall also furnish the editor of the organization newsletter with news items for publication therein, promptly while it still has "news value".

Section 6 Convention. The Convention Committee shall have responsibility for all activities conducted during the annual Convention.

Section 7 Study Group Advisory. The Study Group Advisory Committee shall maintain official record of the activities of approved study groups. They shall furnish assistance and guidance to the study groups including, but not limited to, suggested topics for meetings, group projects, and research activities. They shall, further, make newsworthy information and current listings of contact representatives available to the Publicity Committee.

The Committee shall consist of five members including not more than two members of the Board of Directors, and the remaining members must, after April 1975, be members of approved study groups.

Section 8 By-Laws. The By-Laws Committee shall review and make recommendations to the Board of Directors regarding needed or proposed amendments to the Constitution and/or By-Laws. This committee's activities will best reflect the changing needs of the organization.

#### **ARTICLE VII - ELECTION OF DIRECTORS**

Section 1 (a) The Directors of the organization shall be elected by mail, prior to the annual meeting each year. (b) At the regular meeting six months prior to the annual meeting, the President shall appoint a Nominating Committee of at least three members, the chairman shall be the immediate past president, then an active member of the organization. Should the immediate past president be unable to chair this committee, the Board of Directors shall appoint a chairperson selected from the committee. (c) At the regular meeting three months prior to the annual meeting the Nominating Committee shall present a report, giving the number of Directors to be elected and presenting one or more nominations for each vacancy, at which time additional nominations will be entertained from the floor. (d) The consent of all nominees must be obtained prior to his/her nomination.

Section 2 (a) At least 30 days prior to the annual meeting, a ballot containing all nominees for Board vacancies, will be mailed to the entire voting membership. This ballot must be returned to the National Cambridge Collectors, Inc. no later than 7 days prior to the annual meeting. (b) The results of this ballot shall be announced at a membership function prior to the annual meeting. (c) The nominees receiving the largest number of votes so cast shall be declared elected for the term of office beginning at the close of business of the annual meeting.

Section 3 Election of Officers. Officers shall be elected as provided in Article V of the Constitution. (a) This shall occur at a special meeting of the newly established Board of Directors, at a time which shall not exceed 30 days after the annual meeting (b) All nominees for office must have previously agreed to accept their nomination. (c) Officers shall assume duty immediately upon their election.

Section 4 The Board of Directors shall consist of 12 members elected from the roll of active voting members. The term of office shall be for 4 years.

To provide for continuity of operations the original Board of Directors shall serve for the following terms:

- 3 persons for 1 year March 1973 to May 1974
- 3 persons for 2 years March 1973 to May 1975
- 3 persons for 3 years March 1973 to July 1976
- 3 persons for 4 years March 1973 to July 1977

#### ARTICLE VIII - MEMBERSHIP DUES

Section 1 Annual membership dues shall be as determined by the Board of Directors.

Section 2 Family Member. Each additional household member is eligible to become a voting member upon payment of prescribed dues per year.

Section 3 When Payable. All dues shall be payable when billed by the Treasurer. No member shall be deemed in good standing who is in arrears more than 30 days in the payment of his dues.

#### **ARTICLE IX - RESOLUTIONS AND SUBSCRIPTIONS**

Section 1 No resolution or motion to commit this organization on any matter shall be considered by the organization until it has been considered by the Board of Directors. Such resolution or motions, if offered at an organization meeting, shall be referred, without discussion, to the Board, which after having given consideration to the matter shall submit its recommendations to the organization. Having received the recommendations of the Board, the organization may then proceed to take such action as may seem proper to the majority.

Section 2 No assessments shall be permitted to be placed upon the membership of the organization, neither shall any person or organization be permitted to appeal for funds for any purpose whatsoever before a regular meeting of the organization.

#### ARTICLE X - TERMINATION OF MEMBERSHIP

Section 1 Resignation. Resignation of any member when delivered in writing to the President or Secretary shall become effective immediately upon its acceptance by the Board, providing all indebtedness of such member to the Club has been paid.

Section 2 Non-Payment of Dues. Any member owing dues or otherwise indebted to the organization for a period of 30 days from the date when same becomes due and payable may be suspended and deprived of all privileges of the organization. If he applies for reinstatement within sixty days from the date of such suspension and pays all amounts owing to said date, the Board of Directors may, in its discretion, reinstate the member to good standing, otherwise he shall stand dropped from the roll of members.

Section 3 Misconduct. Any member who by personal or business conduct violates the principles or ethics of the organization may be expelled from membership by the Board of Directors by a two-thirds vote of the entire Board, at a meeting called for that purpose, provided that said member shall have been given ten days notice in writing of such pending action together with a copy of the complaint against him, and shall be given an opportunity for a full and fair hearing.

#### ARTICLE XI - AMENDMENT OF BY-LAWS

Section 1 These By-Laws may be amended by a majority vote of the Active members in good standing present and voting at any regular meeting of the organization after recommendation by the Board of Directors, or by any twelve active members, provided written notice of such proposed amendments shall have been given to all active voting members at least ten days prior to the meeting.

No amendments or additions to these By-Laws shall be made which are not in conformity with the organization Constitution.

#### **ARTICLE XII - APPROVED STUDY GROUPS**

Section 1 Application for Approved Status. Any three or more members in good standing may make written application to this organization for recognition as an approved study group. Such application shall be reviewed by the Study Group Advisory Committee and a report shall be made to this organization recommending disposition of the application. The application shall include an initial membership list, designated contact representative of the study group, and such other information deemed necessary for the official record.

Section 2 Name. The name of an approved study group shall be "Cambridge Collectors Study Group No. \_\_\_\_". Study Groups shall also be encouraged to adopt an additional common name of their choice.

Section 3 Membership. All members of an approved study group must be members in good standing of this organization and shall have a sincere interest in the study and collecting of Cambridge Glass. Study groups shall be limited to a maximum of twenty members. No additional membership requirements shall be made.

Section 4 Meetings. A minimum of eight study group meetings shall be held each year for the purpose of studying Cambridge Glass or closely related subjects.

Section 5 Reports. The study group shall submit a monthly report to the Study Group Advisory Committee for the purpose of maintaining the official record of the activities of the study groups. The report shall include any changes in the membership or designated contact representative of the study group, a summary of activities and subjects discussed and other matters specified by the Study Group Advisory Committee.

Section 6 Authority. A study group shall have no authority to commit this organization on any matter.

Section 7 Termination of Approved Status. Termination of the approved status of a study group shall become effective upon acceptance, by this organization, of a recommendation of discontinuance made by the Study Group Advisory Committee. Such a recommendation shall be made, 1) if requested in writing by the members of the study group, 2) for non-compliance with the rules and regulations of this organization, 3) due to inactivity for a period exceeding six months, or 4) due to conduct which violates the principals or ethics of this organization, provided that the contact representative shall have been given ten days notice in writing of such pending action together with a full statement of the reason for the recommendation, and shall have been given an opportunity for a full and fair hearing.

vases were produced only in crystal.

In January and February 1954 Cambridge brought out their Milk Glass and Ebon (a matte finished black color) lines. No new molds were created for either color. Ebon was used primarily, if not entirely, in molds from the Cambridge Square line, while many older molds were dusted off and used for the Milk Glass line.

Cambridge milk glass was produced only until the factory closed the following summer. During this short production run, vases from the Caprice line #344 (W125) and #337 (W124), and the Everglade vases #20 (W129), #21 (W128), #22 (W127) and #23 (W126) were made in milk glass; as was the Cascade #573 (W133)



Three vases from the Cambridge Square line, #78, #80 and #91 were produced in ebon and these may be found plain or decorated with the gold D/Birds and D/Stars decorations. Production of ebon ceased with the plant closing in the summer of 1954. There is no indications that ebon was made during the reopen years.

Enclosed find picture of the Time Clock that Herschel Hancock purchased <u>used</u> in 1920. It was used continuously in the Cutting Department until 1954. Then it moved to LaFlo Cut Glass Co. and was used there until 1983.

It keeps perfect time and must be wound twice a week by a 4" key. There were containers on either side for the workers cards, to ring in and ring out.

It was made by International Business Machine Company.

I am keeping it for my son, but thought you might enjoy the picture.
