## From The President's Desk

Summer is about to turn into Fall, at least officially, in about three weeks. In the more northern parts of this continent, including Alaska, fall is already here and winter is not far away. Here in south Florida and other southern areas, summer will be with us for another month or more and then a subtle change will be noticed. For most of the United States, September does mean the beginning of fall weather with its cooler temperatures.

It was rather warm the first weekend in August when members gathered at the Museum for the annual picnic and August Quarterly meeting. Most of the people in attendance were from Ohio, yours truly being an exception, and with them came an abundance of good food, including one of the best chocolate cakes I have ever tasted.

Prior to the picnic, as well as via telephone the previous Monday evening, your Board of Directors met and many of the issues raised in my August message were addressed. Foremost was the need to increase the club's income designated for Operating Expenses, primarily publication of the newsletter. Since the primary source of income for this purpose is membership dues, the Board, in accordance with our Constitution and By laws, voted to raise Master membership dues from \$13 to \$15 per year, effective October 1, 1989. All renewals due between now and October I will be at the old rate.

All renewals due on October 1, 1989 will be at the new rate. New members as well

will pay the old rate until October 1. No provision was made for early payment, that is you cannot pay now if you are due in November. It is believed no additional increases will be needed for several years to come, nor will there be an increase in Associate member dues. The increase will insure we will have no operating expense deficits in the next few years, as well as giving us a small cushion for unexpected expenses.

Consultants have examined our museum property and have made several suggestions for resolving our drainage problem. It was stated that much of the standing water problem was no doubt unique to this year and the heavy, consistent, rain experienced during the spring. However, it was agreed we do have some problems and the initial

Since we now make the bobeche in colors we want to call your attention to the console sets listed in C/L #58 - 1933. These are set made by using the #1348 and #1349 - 4 toed Fancy Bowls and the #993 - 4 toed Round Bowl with the #3500/32 prism Candelabrum.



# Club News

National Cambridge Collectors, Inc. Quarterly Meeting August 5, 1989 Storage Building, Museum of Cambridge Glass Cambridge, Ohio

The meeting was called to order at 1:25 p.m. by President Nye. In attendance were nine Board members and 25 club members.

The minutes of the previous meeting held on June 25, 1989, were read by J.D. Hanes. They were amended to read, under Old Business, paragraph 2, "Any amount given in the Fund Raising Drive will have the donors name listed." Phyllis Smith stated there should be another correction, but could not say where. President Nye reserved the right to amend the minutes at the next meeting.

The treasurer's report was given by Bill Smith. As of June 30, 1989, our Operating Equity was \$26,955 and the Museum Equity \$132,525, for a total of \$159,480. Bill reported that this is an increase of \$9,500 since January 1, 1989. He then reported that for the first six months of 1989 we had received donations totaling \$5,173, compared with \$3,390 for all of 1988.

He then reported that with the new Color book price guide and the Rosepoint book, our total book sales for the first six months of 1989 were \$2,078, compared to \$2,346 for all of 1988.

He also reported that the Flea Market profit had increased from \$905 in 1988 to \$1,058 in 1989.

Bill then reported that our cash on hand as of June 30, 1989 was \$15,037.32 in the checking account and \$12,877.29 in the Money Market account. He stated that as of today, these would be less due to paying the costs of publishing the Rosepoint book.

Bill Smith then reported that we hope, in the near future, to have the 1930-34 and the 1949-53 catalog reprints published again. They will be soft bound, most likely.

COMMITTEE REPORTS

BUDGET & FINANCE: No report.

BY-LAWS: No report.

CONVENTION: Chairman Mark Nye reported that it was a success and was over with. The comment sheets were about what he expected. He also stated that next year all of the reports will be heard during the Annual meeting. Mark also reported that of the comments given on the Coffee with Cambridge, all of them were positive. He also stated that at the Banquet we have 20 to 22 Banquet tables. We need more console sets for them. This way we do not have to borrow them from the Dealers in the Antique Show. This in turn can lose sales for dealers in the show. He stated that if we do not get enough bowls loaned from attendees, we can use plastic.

MEMBERSHIP: Chairman Phyllis Smith reported that we now have 931 individual members, 363 associates and 7 honorary, for a total of 1301. She stated that the roll usually fluctuates with new members and drops. She stated if we could stay at 1300 or above that would be great. She stated that we have had a lot of new members recently.

MUSEUM FACILITIES: Chairman Willard Kolb reported that on the following Tuesday they hope to have the county water hooked up. He also reported that he had met with representatives of the Water and Soil Conservation District. Their recommendation was to first fix the drainage of the spring on the hill by the Storage building. Then, later to work with pipes and drains to correct the other problems. They also said that with all of the rain we have received this year, it was not unusual to have drainage problems.

MUSEUM INTERIOR: Lynn Welker showed a donation from Helen and Bill Clark, in honor of Willard Kolb, for all of his work at the Museum. It is a figurine from Jamestown.

AUCTION: Chairman Lynn Welker reported that the Auction will be held on March 3, 1990. The March date is due to the fact of February being "short" and hopefully this will get clear of bad weather. Lynn then reported that he will be taking lists of glass for the Auction from September 1 to October 1. Lynn restated that this is lists only, and for no one to send in glass. He reported that the Quarterly meeting will be on March 2, 1990.

At their August meeting, the Board of Directors selected a token of appreciation that is to be given to each contributor of \$104 to the Fund Drive. For the time being its nature will be kept a secret except to say it will be made of glass. We hope to be able to present the item to the first group of eligible recipients at the November Quarterly meeting. It is a unique and desirable item and the only way you will be able to obtain one is to donate the full \$104. A couple donating \$208 will receive two, but a couple donating anything less will only get one.

In my initial article dealing with this Fund Drive, I stated that in lieu of cash, glass for the Museum as well as goods and services applicable to the Museum operations were acceptable. Some questions have arisen and I hope to resolve these issues here.

Glass will be counted at fair market value, with the donor providing a value at the time of donation; however, if there is any dispute regarding the validity of the established value (for example the value of a piece has been grossly misstated) the final value will be set by the Museum Acquisition Committee. Goods will also be counted at fair market value, best established by the donor providing receipts or other current indications of value.

When I used the term "services," I did not have in mind the normal volunteer labor

expended in the routine upkeep of the building and facilities. I was thinking along the lines of specialty services such as printing, land-scaping, roof repair, paving, fencing, etc., donated by an individual whose business it is to provide such a service for a fee. If there are any further questions, please address them to me and I will see they are answered in a future issue.

Overall, the drive is progressing along the lines I thought it would. No large sum of money has yet been raised, nor did I expect it would be by this time. What I do hope is that each and every one of you who have not yet donated, are busy putting aside your dollar each week so that come February, 1990, we will reach the half way mark of \$50,000.

Churches with membership equal to or less than ours are able to raise much more substantial sums of money for building funds; hence we should be able to raise \$100,000 over the two year period. If every member gives her or his fair share, the goal will be reached.

# **Transparent Colors**

PART VIII

We ended last time with a letter from the Cambridge Sales Manager, Mr. McCartney, to all Cambridge customers, which in essence told them of the end for many Cambridge colors. The letter lacks in detail, but the next available color listing, dated January 1945, included only three transparent colors: amber, amethyst and moonlight, along with crystal and the opaques coral and crown tuscan. (The latter two are believed to be the same color with different names for marketing purposes.)

At the present time, we have little Cambridge advertising dating to 1944, and none of what we have makes mention of color. Throughout 1945 and 1946 no specific mention of colors are made in Cambridge advertising. "Crystal and Colors" was used in many of the advertisements, but no precise indication of what was being made in color was provided.

At the present time, we have no 1940s price lists dated after January 1940. Thus, we are unable to determine what items were made in color between 1943 and the next known price list which is dated June 1949. From a Cambridge diary for 1947, we know amber, moonlight and amethyst colored glass continued to be offered, and in all probability, Caprice was being made in crystal and moonlight throughout the 1940s.

The June 1949 price list makes mention of moonlight, amethyst, amber and to some extent, gold krystol. The latter was being used primarily for ash trays and two tumblers, including the Georgian #319. All of the Caprice then being offered was available in both crystal and moonlight. Other use of color was mainly limited to smoker sets, tumblers, vases, decanter sets, and a few candleholders being made in moonlight. The latter consisted of the  $2\frac{1}{2}$ " and 4" stars, along with the #646, #647 and #1338 candlesticks.

August 1949 saw the introduction of two new colors, emerald and mandarin gold. As an example of how confusion regarding color names arises, an August 1949 news article from China, Glass and Decorative Accessories listed the new Cambridge Colors as "Emerald Green and Mandarin." Crockery and Glass Journal in its July 1949 issue had the

following sentence in a news item, "Additional news from Cambridge . . . Some exclusive gift merchandise will also be shown, such as cigarette boxes, compotes, unusual console sets, vases, and a short informal bridge set in two new colors -- apple green and honey gold." It is from subsequent Cambridge price lists the actual Cambridge names were identified as emerald and mandarin gold.

A new price list was issued in September 1950 and it contains more extensive listings for color than seen in the late 1940s, but the age of color, as it was known during the late 1920s, 1930s and on into the early 1940s, had past into history. As a part of the color revival, ebony and carmen found their way back into the Cambridge line as early as the Spring of 1950, if not before. Some 30 pieces of ebony ware were being offered in the Fall of 1950; while in carmen, the #3103 stemware, three sizes of swans (3". 6½", and 8½"), the #3011 or Nude cocktail, and 14 other items were available.

From the March 1950 issue of China, Glass and Decorative Accessories comes the following:

"New at Cambridge Glass is the 'Esquire' line of 'stemware without stems,' with crystal bowls and feet of crystal, ebony, emerald, carmine or amber, to retail at \$18 per dozen. Very modern too, is the 'Ebony' line of vases, bowls, ash trays, candlesticks, etc. And the figure cocktail and cordial glasses are back with the crystal figure in the foot and bowl in amber, emerald, amethyst or mandarin gold, to retail at \$1.50 apiece."

(Editor's Note: The Esquire line includes the Game Set with club, heart, diamond and spade foot shapes, and originally included what is now known as the Tuxedo line.)

The revived interest in color did not persist and by the fall of 1953, ebony and carmen had once again been discontinued and only limited use was being made of amber, amethyst, emerald and mandarin gold. Decanter sets, #1066 stemware, Jefferson stemware, four (4) jugs from the #3900 line (#115, #116, #117 and #118) along with two (2) tumblers (#115 and #117), Tall Joes, Little Joes and the #3011 brandy and cocktail, along with a few other pieces, were all that was offered in color when the October 1953 price list was issued.

The reopening of the factory in Spring 1955 was followed by another color revival. Two totally new colors, smoke and sunset, were brought out. Pink, amber and pistachio were reformulated and put into production; and production of amethyst, carmen, emerald and mandarin gold resumed with no discernible change in the colors. This was also true of moonlight, even though it was now being called moonlight blue.

Smoke is a medium shade of transparent gray and many pieces found in this color, when looked at very carefully, will have a strong suggestion of amethyst. Sunset, a multicolored "color," is very similar to rubina. According to the book "Colors in Cambridge Glass," sunset "is a beautiful dark red at the bottom of the item shading through yellow and sometimes green into a light transparent blue, topped off by a thin line of yellow and red at the top."

The reopen period amber is darker than its predecessors and this, plus shapes unique to the period during which it was used, will aid in its identification. The reopen pink is not unique even though it does differ somewhat from peach-blo (dianthus pink) and la rosa, and can, in most cases, only be identified when found in a Cambridge shape used during the reopen years. The reopen pistachio, while it is a light transparent green, is not the same as the earlier color of the same name. Until the collector has become familiar with the late pistachio, the best means of identifica-

tion is the piece itself. When discussing these three colors, the collector is urged to preface each name by "late" or "reopen," since there are earlier colors of the same name.

Among the items offered in color during 1956 were seven (7) items from the Nude line consisting of: the table goblet, saucer champagne, cocktail, brandy (then being called a cordial), ivy ball, comport and ash tray. The cordial was listed as then being made in amethyst, amber, emerald and mandarin gold; while the balance of the items were stated to be available in smoke, pink, mandarin gold, moonlight blue, pistachio and carmen. In addition to these colors, the cocktail continued to be available in amethyst, amber and emerald, as well. Crackled Nudes were also produced during 1956 and are listed in the 1956 price list as coming in pink, mandarin gold, moonlight blue, smoke and pistachio.

Other items offered in color during the reopen years, included: tumblers, vases, ash trays, stemware lines #1066 and #1401 (Jefferson), and from the Georgian line the 5 oz. & 9 oz. tumblers, candy box and cover, two styles of handled baskets, and the 5 oz. sherbet. A complete listing of all items manufactured in color during the reopen years is beyond the scope of this article.

A new price list was published in 1958 and it

### **Convention Postscript**

For many, the Annual N.C.C. Convention ends sometime on Sunday, but for a few of us, the work goes on for several more weeks. Bills must be paid, thank you letters written, books balanced, evaluation reports read and a summary prepared, etc. After all this, then the convention becomes history and work can begin on next year's event.

The main purpose of this article is to review the comments made on the evaluation forms and offer a response where appropriate. We had a total of 210 paid registrations for the 1989 Convention, and of this writing (mid July), we have received 16 evaluation forms.

For those of you who commented on the location and the facilities, the current site is the only one in the area large enough to accommodate all functions under one roof. In addition, there is no other dining room in Cambridge large enough to hold our meal functions. There is no single facility between Columbus and Pittsburgh that can handle all our functions under a single roof. The Board will again review this issue, but short of a miracle, there is little that can be done in the immediate future. Suggestions have been made to move to Zanesville, but then we are at some distance from the Museum, and even there, no facility could handle all the functions.

Believe me, something will be done about assuring that a working public address system be in place prior to the start of next year's convention. I agree with each and everyone who made negative comments about the poor quality of the system, or the lack thereof, on Sunday morning.

The suggestions regarding the Friday night menu will be passed on to next year's convention chairman. Hopefully a different menu can be offered, with little change in cost.

Two of the questions on the evaluation form dealt with convention activities. For the most part, those responding felt the number of activities, and their nature, met our needs. One person suggested we have a demonstration of the etching process next year. This might be possible, but only up to the point where the piece goes into the acid bath. It

would be virtually impossible to include this step in the demonstration due to the hazardous nature of the acid and the facilities required for its use. Some discussion has taken place regarding using videotaped programs. It is possible we may be able to present some in this format at next year's convention.

"Coffee with Cambridge" proved to be a success. Those who commented they missed the display room also realize the practical aspects involved in arranging the display and its duplication of the Museum displays. The suggestion the Museum be opened for additional hours during the latter part of Convention Week will be taken under advisement.

Due to the time required to set up the banquet tables, make the flower arrangements, etc., there is little possibility the room could be opened for viewing prior to the President's Reception. It also needs to be empty as long as possible to "cool down" as much as possible. For those of you who missed the punch bowl, if it is of any consolation, so did I. I did not know one was going to be offered, nor did I see it, until after the banquet. Sorry.

A suggestion was made that the programs using transparencies be made into a book or notebook with the narrative as captions and sold to club members. If you, as a member, think this is a good idea, send a post card to the post office box expressing your interest in such a project.

Several good suggestions for a Convention theme were received and all will be considered. One particular item appears to be of interest to many members, and that is, candlesticks. While I can't promise you that will ever be used as a convention theme, I will make every effort to put together a program on candlesticks for next year's convention. The possibility of a book on candlesticks is rather remote at this time, perhaps a booklet would be more feasible. Again, let us know your wishes. Those ideas that cannot be used for convention themes will be given consideration as topics for articles to be published in the CRYSTAL BALL.

Several other comments and suggestions were made. It is only through your comments that we know what you, as members, want out of the annual convention. While it is not possible to incorporate every suggestion, due consideration will be given to all those received.

was destined to be the last issued by the Cambridge Glass Co. Color continued to be a part of the Cambridge line with, amber, amethyst, carmen, emerald, mandarin gold, moonlight blue, pink and smoke, the listed colors. Gone were pistachio and sunset, but listed under colors, was Mardi gras. Mardi gras is not a true color in the sense of pink or smoke; rather, Mardi gras is crystal glass that has been rolled in flecks of colored glass prior to being formed into objects of rather unusual shapes, primarily vases. A few standard Cambridge items, including the Sea Shell #46 shell flower holder, are also known in Mardi gras.

White Rain and Blue Cloud are similar to Mardi gras, but precede it by at least a year or more. Known in footed tumblers and stemmed sherbets, these were made using flecks of a light pink opaque and a light blue opaque glass, respectively. Also known are items using orange flecks and these may have been called "Strawberry."

None of the existing price lists from the reopen period indicate that production of Caprice in moonlight blue took place during those years. Previously known (prior to the advent of reproductions) was an unexplained Caprice butter dish in moonlight blue. A few years ago, a number of turn cards used to indicate production, became available to the club and among these have been found several showing production of moonlight blue Caprice occurring in late September 1956. To what extent it was produced or for how long is not known at this time.

There are indications additional colors were being developed during the reopen years, but now appear to have been produced commercially. With this, we have come to the end of the Cambridge transparent colors.

Only a fraction of the items manufactured in transparent colors have been discussed or listed in this series of articles, that began almost a year ago. There is no comprehensive list of colored items, nor, practically speaking, could one be generated. The interested reader is urged to study existing references and visit as many shops and glass shows as possible to obtain a wider knowledge of Cambridge in color.

step to resolve them will be digging a new ditch along the storage building service road in order to drain off the water from the spring located behind the building. This will be done in the near future. Other ditching needs to be done, particularly at the bottom of the hill and along the township road, but this probably will not be done immediately. While on the subject of water, the museum will be connected to the county water supply by the time you read this. Plans for it will take place during the first week of August.

The Board is in agreement that the Museum will remain at its present location, the existing building should not be expanded; and that the logical place for a new museum building would be between the existing museum building and the storage facility. No specific plans have been formulated, nor is it anticipated such will be done in the immediate future; however, all improvements to the museum grounds will be carried out allowing for the proposed location of a new building.

Collector Books is investigating the possibility of reprinting the 1930-34 and the 1949-53 catalogs in soft bound editions. There is little or no chance they will be reprinted in the previous hard bound format. More on this in coming months.

For news regarding the Fund Raising Drive, see the separate article published elsewhere in this issue.

It has been suggested a set of slides or photographs showing the interior of our museum be prepared and made available to members who are unable to visit Cambridge. The Board agreed this was an excellent suggestion and will arrange for this to be done.

Published in this issue are the 1989-90 Committee chairmen appointments. Anyone desiring to work with any of the committees, please contact the appropriate individual. We do need individuals from the Cambridge area to work with Willard Kolb and Doyle Hanes in maintaining the Museum buildings and grounds. 
