## President's Message

# *Confusion*

We received the money from the Shepard Grant; we must now document how we will use this money and track its use. Many thanks to all those involved. Next focus is the Kiwanis Grant, which is now being worked on by the same group. Good luck. Thanks to all of you who attended the August quarterly meeting. Members came from Florida, Michigan, New York, New Jersey, Virginia, and Ohio. I am sure I have missed a state, but it was a good crowd for August.

Many people were confused about the intent of the NCC Board of Directors in regard to the new property and the actions which were to take place at the August quarterly meeting. First let me say, it was never the intention to build a new museum based on the vote at the August quarterly meeting. The timing of the Crystal Ball publishing does not allow us much time to make timely announcements of action to be taken. At the end of June, we placed the old museum property on the market. My message and the article by the Museum Relocation Committee had to be submitted to Lorraine by July 10, therefore we had to ask that the membership be ready to vote on the possible relocation of the storage facility if the property had sold. As the circumstances played out, we did not have to deal with that issue at the August meeting, therefore no vote was required.

When we listed our property, it was noted that we could either get an offer quickly or it would take an extended period of time to sell the property. Well, it appears that it may likely be the latter of the two. This negates the problems that a quick sale was potentially presenting to us.

I had thought we were clear on the intent, but perhaps we could have been more precise. The Board is elected to conduct the business of the organization, but the membership needs to take an interest and attend the quarterly meetings even though there may not be an event scheduled. To do the business of the club, we have to make decisions quarterly. Unfortunately, the August meeting is the only meeting where we do not have an event scheduled and as such, attendance is usually light. However, we still need to be prepared to act if any decisions have to be made. Any suggestions to boost attendance at the quarterly meetings would be appreciated. Plus, we welcome any members at all quarterly meetings to have their voice heard. Our

elected Board members make a lot of commitment to come to quarterly meetings to help move forward the business of the club. They work hard to make sure that our 1400 members are represented fairly. Not everyone feels that they do, but we welcome anyone to come to a meeting to see how items are discussed in depth, fairly, and earnestly to represent the entirety of the membership.

On to other things ... now you have had the opportunity to review the land layout, what do you think? Write and let us know. Some of you have already let us know what you want and we appreciate that information. While you are thinking about the property, keep in mind that we must be able to *support* any museum we build, so ongoing operational costs will have to be taken into account. How much money will it take to operate the structure? How many people will it take to run the facility? Parking is another consideration as is the storage building. I believe the latter is best solved by placing the location on the narrow section of the property between the property boundary and the sewer line. Let me know your opinion.

We are working on obtaining the architect who will really present us with the options for the structures. When we have more information on this, it will be passed along. We're also organizing subcommittees to evaluate each area thoroughly from design to finance. We welcome your input to these volunteer committees.

The Scotty Dog project is doing well. We are currently looking at the possibility of a new color for 2000, but more on that from the project committee after the tests are done. We are announcing a special sale on the 1940 catalog. It is now \$25 until the end of the year. If you have thought about buying the catalog, now is the time. Think about this as a Christmas gift. It's not too early. I have already received many Christmas catalogs in the mail since August.

Have you signed up a new member recently? I believe the joy of collecting is enhanced by membership; perhaps a gift of a membership to a friend? We all have to work on this issue.

We still have shows coming up and we need all the help we can get. If you can be of help, let us know so we can

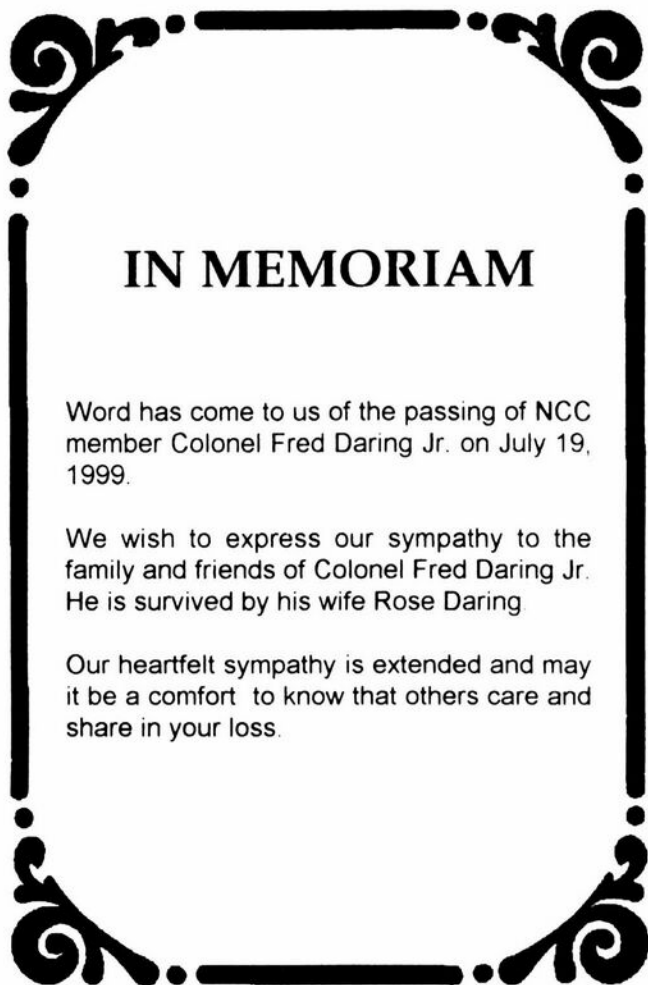

# June Annual Meeting Minutes

## Pritchard Laughlin Civic Center

### Cambridge, Ohio

### June 27, 1999

At 9:27 a.m., President Rick Jones called to order the 26th Annual Meeting of NCC, Inc. A motion was passed to dispense with the reading of the March Quarterly Meeting Minutes and to approve them as published in the *Crystal Ball*.

Charles Upton presented the **Treasurer's Report**. Fund balances as of April 30, 1999 are: Operating Fund, \$47,117; Museum Fund, \$208,582; Building Fund, \$63,126; and Endowment Fund, \$10,820; for a total equity of \$329,645. Last year's total at this time was \$269,975. Charlie then turned over the rest of the reporting to Dennis Snyder.

Dennis began his report by explaining that our financial operations are in two categories: basic operational and investment. For discussion purposes, he pulled out donations. They are usually included, but are pulled out because of the extraordinary circumstances with the flood. Our operating income has increased by 55% even with the flood. Earnings from our investment portfolio are up by 47%, that is, they grew by 47%, which is over \$15,000. The flood loss, as near as we can calculate it, is \$17,476, which includes the abandonment loss of the building. Donations have increased from around \$11,000 to just over \$30,000. The bottom line for 1998 is \$34,500, as opposed to \$26,000 from the prior year, so we have had some good growth. So far in 1999, we have \$13,000 in investment earnings and \$7,000 in donations. We have sold 202 Scotties through April, totaling over \$17,000. This figure can only include those Scotties that are in the hands of their owners. Dennis discussed the five investment categories over which our funds are distributed. Last year the overall rate of return was 11%. Dennis stated that he could remember years ago when we had \$25-28,000 in our investment portfolio, and now we have almost a quarter of a million dollars.

Committee reports were presented from the following committees:

**Acquisitions:** Rick Jones talked about our acquisition strategy due to the flood. We had pulled back from purchasing glass with the exception of some selected items.

**Corresponding Secretary:** Charlie Upton announced "Thanks for all the mail!" and stated that everything is going well. Please include your membership number and expiration date when renewing your membership.

**Membership:** Jeff Ross reported totals of 1,018 master members, 386 associates, 3 lifetime, and 4 honorary, for a total of 1,411 members. This included 15 who signed up at the Convention and also those who have joined by our presence at glass shows. This is the first time in a while that our master member total is over 1,000! Jeff reported a good response from past-due notices sent out during the flood catch-up time. He also reported that 1,400 new permanent membership cards are sitting on his dining room table. They just came in this week and not in alphabetical order or any kind of order! Jeff's intent is to mail them out with the August *Crystal Ball*. Hold on to your new cards, and do not send them back when renewing your membership. You can send back the postcard notice, or your mailing label which will also have the information on it.

During Convention, people have agreed to help Jeff with the Regional Program. They are Jim and Nancy Finley in the Missouri area; George and Jo Fogelson in Portland, Oregon; Marge and Emil Kleeman in Connecticut; Bob and Karen Arnold for part of Pennsylvania; Shelley and Alex Citron in Virginia; and Fleur de Lys Healy in Orlando, Florida. Jeff is also working on getting someone for Southern California and for Minnesota.

Rick Jones announced that we have been invited by Old Dominion to set up a club table at the glass show in northern Virginia during the second week of November. Rick also talked about the "NCC Traveling Road Show" and that its focus has been on etchings, which went along nicely with the new Etchings Book. Color themes and Nearcut have also been featured at Harrisburg.

At this time, Jeff listed the names of those who we have lost over the past year, and club members took a moment of silence to remember them.

**Museum Facilities:** Club members thanked Carl Beynon for keeping up the property.

**Museum Interior:** Marybelle Teters said that she was sorry we did not have one [a museum], but we are looking forward to a new one. Marybelle also gave a big "Thanks to everyone!" She has pictures of the flood if anyone would like to see them.

Rick Jones stated that we have received donations from

over 25 glass clubs and shows totaling around \$18,000. If you are associated with anyone who did not receive an acknowledgment letter, Rick apologizes. He has sent out 132 letters in January and February, and he will send another 35-40 letters soon.

**Non-Glass Items:** Tarzan Deel reported that over Memorial Day weekend, they went through the freezers to categorize paper. Some can be taken care of in town, and Carl Beynon is helping with that. Other paper must be sent out of town to process, probably sometime late fall. Mark Nye and Tarzan also spent time before Convention in going through paper. Thanks to Ron Hufford for loaning his freezer.

**Program:** Bill Hagerty stated that programs are at a standstill right now, but he will let you know in the *Crystal Ball* about what's coming up. There are some ideas for November, such as toy candy containers. Bill would like to hear from anyone who would like to volunteer for a program.

**Projects:** Bill Hagerty reported that salt and pepper tops are still for sale. An ad has been placed in the *Daze* for Scotties. Frosted Scotties will be sold all through 1999 also. Bill stated that we have sold 490 pair of Scotties, which cost around \$10,000 and cleared around \$40,000. They were also boxed and shipped from Mosser's, which saved us even more. Right now we have around 100 pair to sell. Thanks to Leslie and Bill Connors who had the idea! Rick Jones stated that the Scotties are one of the most successful programs which this club has ever had. It was suggested that we put an ad in the Wee Scots' club newsletter about the pair of teal Scotties to be sold at our March auction to give them the opportunity to bid on them also.

Rick reported that on Friday night of Convention, Willard Kolb raised well over \$4,000 with the mini-auction.

**Publicity:** Cindy Arent thanked Mike Neilson for all of the local publicity in the newspaper, and she also thanked other local support such as Reisbeck's and Penny Court. Cindy reported that the response from the media kits was pretty good.

Cindy also talked about the grants which are being pursued, and she thanked everyone who has helped with grants. An application has been submitted for the McManus-Shepard Fund and we have asked for the \$5,000 maximum. The Kiwanis grant will also be submitted at the end of August, probably for another \$5,000. Sharon Miller and Cindy both took grant-writing classes to be able to do this. If anyone has any experience in writing grants and would like to help, please let Cindy know.

**Study Group Advisor:** Marybelle Teters thanked our study groups and turned it over to the individual groups to present their reports.

Pam Earussi reported for the Elegant Glass Collectors' Study Group. They did much work this year at the Harrisburg Show and are anticipating the next one around November 20-21. The tote bags brought the NCC a check for slightly over \$1,000.

George Stamper reported for the Miami Valley Study Club. He announced a total of 31 members, 28 of which were present at the Convention at one time or another. A lot of work was completed by their "Flood Brigade," and Ron Hufford had donated use of a freezer to preserve paper. Their biggest project this year was to help with Phyllis Smith's auction, and Phyllis contributed a check to the NCC from the auction sales.

Sharon Miller reported for the Cambridge Cordials Study Group. Recently, they put up a sign at the future site of the new museum, which was featured on the front page of the local newspaper. The raffle for the green Caprice bowl brought in \$243, and the 50/50 raffle, \$402. The 50/50 raffle was won by Les Hansen, and he donated back his half. A raffle for the Paul White picture also brought \$160. T-shirt sales have brought in around \$1,000. Today, the Cordials are sponsoring the Workers' Reunion.

**1999 Convention:** Mark Nye said thanks to all for coming! He also thanked a lot of people who helped to make the 1999 Convention such a success. Mark acknowledged All Season Florists in Byesville who contributed to our floral arrangements, and he thanked all who helped and donated.

**1999 Auction:** Lynn Welker reported that this year's auction was incredibly successful. He thanked Squeek and Dorothy Rieker, and Tom and Noreen Kullman, and all those who contributed donations and consignments. A notice will be out in the September *Crystal Ball* to state that consignments will be accepted for next year's auction from September 1 through October 1. This year's net auction income was \$6,219.

**1999 Glass Show:** Mary Beth Hackett thanked all of the dealers; 25 dealers from 13 different states. She stated that we had the smoothest unload in the history of the show, completed in a record two hours!

**1999 Glass Dash:** Mike Arent thanked all who helped; Carl Beynon, and all the people who helped set up and tear down, and all the dealers. We had to institute a waiting list this year, and unfortunately, we overbooked. Profits were up this year, totaling \$2,755.67.

**Crystal Ball:** Lorraine Weinman said thanks for all of the wonderful contributions. You may pick up forms for contributions at the registration table. Thanks to Georgia Otten for some of the most entertaining articles!

# Bottles, Console Sets, and More

Page 55 of the 1930 Cambridge catalog featured bathroom bottles. These bottles were labeled, via etching and enameling, for a variety of uses, ranging from cotton to mouthwash. The line consisted of six sizes/shapes of bottles and eleven different labelings: cotton, Epsom salts, toilet water, boric acid, bath salts, bicarb(onate of) soda, witch hazel, alcohol, hand lotion, mouth wash, and Listerine. According to "Etchings by Cambridge, Volume 1," these, for the most part, came with the labeling etched or the background etched with clear (unetched letters).

As was customary, no color information was provided in the catalog. Circular letter #42 from 1932 tells us that four combinations of enamel coloring was being used by Cambridge at that time to decorate the bottles: D/994/1 used black and white enamel; D/994/2, blue and white; D/994/3, green and white; and D/994/4 combined ivory and black.

Circular Letter #42 - 1932 offered only five bottles along with two sizes of trays; Bicarb. Soda, Boric Acid, Cotton, Mouth Wash, and Hand Lotion. (The trays are those shown on the catalog page reprint.) All of the bottles and both trays were available separately or as two sets. The oblong tray came with all five bottles while the square tray set omitted the boric acid bottle. The 1932 list price for the 6 pc. set was \$7.50 and that of the 5 pc. set, \$6.25.

Console sets were the feature item on page 8 of the 1932 Cambridge catalog supplement. During 1932 Cambridge ran a "special" on four different console sets or so indicated circular letter C/L #99-1932 issued January 12, 1932. "Special Console Sets Crystal Only" was the page 2 caption. These sets consisted of a pair of 1307 candelabrum and one of four different console bowls, three of which are seen on the reprinted catalog page;

Decagon 842, Decagon 855 (not illustrated on this page), #992 4 toed bowl with rolled edge and #993 4 toed flared bowl.

The sets were offered with any of three Chintz etchings and with red, black or blue enamel edge. E.758 was referred to in the circular letter as Chintz #1 and with the enamel rim as D/997. Chintz #2 is more commonly known as E.759 and with the enamel rim, it becomes D/998. The third Chintz etching in this offer is called Rose Chintz or E.760 and after the addition of the enamel rim became D/999. In all cases the addition of a 1 indicates red edge (D/997/1); 2 indicates black enamel (D/997/2) and 3, blue enamel (D/997/3). Taking into account all the possible combinations of etchings, enamels and sets, there were 36 different console sets offered in C/L #99-1932!. Try and find all these today. List price for the sets was \$6.60 each and for \$1.25 more, a 518 figure flower holder could be added to any set!

"Cambridge Two Tone 'Quick Sellers'" is the caption found on page 9 of the 1932 catalog supplement. While these pieces were made in other colors, Circular letter #2 from 1932 (no specific date is available) indicates the pieces shown were being offered in Forest Green, Royal Blue, and Amethyst in combination with crystal at a list price of \$15.00 per dozen. Qualifying this price was the following: "Must be ordered in quantity of at least 6 of each item or total of 54 pieces. This may be 2 of each item in each color or 6 of each in any one color."

Our thanks goes to Carl Beynon for sharing these circular letters with us. So much additional information not found in catalogs can be found in material of this type.

**Webmaster:** Rick Jones said thanks to Linda Roberts. Linda really wants membership input.

**Museum Relocation:** Rick Jones lead the discussion on museum relocation, beginning with the fact that we have purchased a piece of property. He stated that a 14-phase program has been developed, of which phases 1-4 are: 1) Property, 2) Architectural drawings, 3) Budget, and 4) Sale of current property. Scott Bennett Realty has recommended that we list our older, current property at \$169,000 for the entire property. To do so, we would put a new storage building on the new property for our molds, paper, and Museum-owned glass. At this point, Rick asked for an open forum to hear what the members think. Questions and ideas flowed from the members present, making a very good discussion. Members would like to be updated every month in the *Crystal Ball*, and maybe have a page in which they can contribute in the *Crystal Ball* and on the website. Funding for the new property was discussed. We have a 5-year payment schedule with a low interest rate, so we will not have to tap into our current investments to pay for the new property. The club also discussed moving the molds and the idea of a new storage building on the new property. Rick brought up the subject of "naming gifts" and stated that we already have three pledges of \$10,000 and one

pledge for materials. Two of these four pledges are for a research room or a library. We have a showcase naming-gift pledge from the 20-30-40 group in Chicago. Rick welcomes ideas and suggestions on naming gifts.

**Old Business:** None.

**New Business:** A motion was made by Les Hansen and seconded by Frank Wollenhaupt that no decision regarding the construction of facilities is made without presentation to a general assembly of the membership at a quarterly meeting with advanced notice being published in the *Crystal Ball* of said meeting. The motion was passed.

The 26th Annual Meeting of NCC, Inc. was adjourned at 11:18 a.m.

## CONSTITUTION

### ARTICLE I - NAME

Section 1 The name of this organization shall be the National Cambridge Collectors, Inc., operating as a non-profit organization under charter granted by the state of Ohio.

### ARTICLE II - OBJECTIVES

Section 1 The members of this organization shall meet together regularly, for the purpose of acquiring a broader knowledge of glassware manufactured by the Cambridge Glass Company in Cambridge, Ohio (1901-1954) and through instruction, discussion and study, actively promote the preservation and collection of Cambridge Glass.

Section 2 The primary objective of this organization is to establish and maintain a permanent museum in Cambridge, Ohio (Guernsey County) for displaying and study of Cambridge Glass. The organization will operate on a non-profit basis and all Moines realized will be applied to this end.

### ARTICLE III - MEMBERSHIP

Section 1 There shall be two kinds of membership, namely voting and honorary.

Section 2 Voting Membership. Any person, age 12 or over, upon payment of the prescribed yearly dues is eligible to become a voting member of this organization. Other qualifications shall be as stated in the by-laws.

Section 3 Lifetime Membership. To recognize outstanding service to the organization, a person may be elected a lifetime member. They will have all the rights of voter members but will not be required to pay dues as long as they remain a member of the organization. The election of a lifetime member shall require the unanimous vote of the Board of Directors by secret ballot.

Section 4 Honorary Membership. Any person who has distinguished himself in an unusual and praiseworthy manner in promoting the objectives of this organization may be elected to honorary membership. Honorary members shall have the privilege of attending all meetings of the organization, but shall not be required to pay dues, or be permitted to vote or hold elective office, and they shall have no interest in any funds or property of the organization. The Board of Directors may designate the time frame for which an honorary member is elected.

Section 5 No territorial limits shall be established for the organization and membership is open to all interested persons.

### ARTICLE IV - MEETING AND FISCAL YEAR

Section 1 Regular meetings shall be held as provided in the by-laws.

Section 2 The annual meeting shall be held as provided in the by-laws.

Section 3 The fiscal year shall begin the first day of January each year.

### ARTICLE V - OFFICERS

Section 1 The officers of this organization shall be a President, One Vice President, a Secretary and a Treasurer elected from the Board of Directors by the Board of Directors. All Officers shall hold office for one year, or until their successors are elected and qualified.

### ARTICLE VI - BOARD OF DIRECTORS

Section 1 The Board of Directors shall consist of 12 Directors elected by the voting members of the organization. Terms of the office are to be as provided in the by-laws.

Section 2 To be eligible to serve on the Board of Directors, a person shall be at least 21 years of age.

Section 3 The Board of Directors shall be the governing body of the organization and shall have power to make such regulation and take such action, not inconsistent with the Constitution and By-laws as, in its judgment, may be necessary for the welfare of the organization. The decisions of the Board in all organization matters shall be final, subject only to appeal to the voting membership of the organization.

### ARTICLE VII - SURRENDER OF CHARTER

Section 1 If this organization deems it desirable, by unanimous vote of the active voting membership, to terminate operation of this organization, all assets, records and Moines shall be turned over the Guernsey County (Ohio) Historical Society with the stipulation that such be used only for the study and preservation of Cambridge Glass. In the event the Guernsey County (Ohio) Historical Society cannot, or will not, comply with above stipulation, it shall be turned over the Corning Museum of Glass, Corning, New York, to be used at it's discretion.

### ARTICLE VIII - AMENDMENT OF CONSTITUTION

Section 1 This constitution may be amended by a majority vote of the active members in good standing, present at the annual meeting of the organization, upon proposal by a voting member in good standing sixty days prior to the annual meeting, provided written notice of such proposed amendment shall have been given to members at least ten days prior to annual meeting.

### ARTICLE IX - ADOPTION OF THE CONSTITUTION AND BY-LAWS

This Constitution shall take effect and be in force upon its adoption.

## BY-LAWS

### ARTICLE I - MEETINGS

Section 1 Regular Meetings. The regular meetings of the organization shall be held during the months of March, June, August, and November at such time and place as the Board of Directors shall designate.

Section 2 Annual Meetings. The annual meeting shall be held in June for installation of elected directors, the presentation of annual reports and transaction of other business. The term of directors shall officially begin at the close of business of the annual meeting. Charter directors shall hold office until their respective terms end, as per Article VII, Section 4 of the by-laws.

Section 3 Special Meetings. Special meetings of the organization may be called by the President or by a majority of the Board of Directors upon regular written notice to the Secretary at least five days in advance of said meeting.

Section 4 Quorum. The majority of the active members in good standing present shall constitute a quorum at any meeting of the organization.

Section 5 Rules of Order. Parliamentary procedure in all meetings of the organization, Board of Directors, and Committees shall be in accordance with the latest revised Robert's Rules of Order if not inconsistent with the by-laws.

### ARTICLE II - DUTIES OF OFFICERS

Section 1 President. The President shall appoint all Committees, shall preside at all meetings of the organization and the Board of Directors, and shall perform such other duties as ordinarily pertain to such office. The President shall be ex-officio member of all committees except the nominating committee. He shall, immediately upon taking office, appoint a Sergeant-at-arms.

In the event a vacancy exists in the office of President, the Vice President shall assume the office and title of President during the unexpired term of the President. The President shall furnish bond in the amount determined by the Board of Directors, the cost of which bond shall be paid by the organization.

Section 2 Vice President. The Vice President shall have the duty of familiarizing himself with all organization affairs. He shall work under and in cooperation with the President and shall preside at meetings in the absence of the President.

Section 3 Secretary. It shall be the duty of the Secretary to keep the official record of all members, voting and honorary, provide verification of voting members as required, record the attendance at meetings of the organization, record and preserve the minutes of such meetings, make the required reports, and perform such other duties as customarily pertain to such office.

Section 4 Treasurer. It shall be the duty of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to this office. He shall collect all dues and funds of the organization and deposit them in bank or depository named by the Board of Directors. Upon his retirement from office, he shall turn over to his successor or to the President, all funds, books and accounts, or any other organization property in his possession. The Treasurer shall furnish bond in an amount determined by the Board of Directors, the cost of which bond shall be paid by the Organization.

Section 5 Salary of Officers. All the officers shall serve without compensation.

### ARTICLE III - BOARD OF DIRECTORS

Section 1 Meetings. The President shall be Chairman of the Board. He shall call regular meetings of the Board at least quarterly. He shall call a special meeting within five days after receiving a written request from three or more board members.

Section 1 Functions (a) The Board shall be responsible for the appropriation of all funds of the organization and shall, through the President or other duly authorized member of the Board, approve all vouchers before payment by the Treasurer. It shall designate the bank or depository in Guernsey County, Ohio for funds of the organization, approve all investments of funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. It shall receive and approve Budget and the annual audit of the financial transactions of the organization. (b) It shall pass on all projects recommended by the Project committee, which must be approved by a two-thirds vote of the entire Board. (c) It shall pass upon all grievances, defaults and complaints by or against a member, and may take such action as it deems appropriate on behalf of or against such member. It may, for good cause, declare an office vacant, upon two-thirds vote of the entire Board. (d) It may fill vacancies that occur during the year. The President shall appoint, and the Board confirm by a two-thirds vote of those in attendance, a member to fill any vacancy occurring. Said appointee shall serve for the balance of the term being vacated.

Section 3 Quorum. A majority of the members of the Board shall constitute a quorum.

Section 4 Resignation of Board members. All resignations from the Board, except for those covered under Article X, shall be made in writing to the President.

### ARTICLE VI - APPOINTED OFFICERS

Section 1 Sergeant-at-Arms. The President, immediately upon taking office, shall appoint a Sergeant-at-Arms. It shall be the duty of the Sergeant-at-Arms to preserve order at all times and perform such other duties as ordinarily pertain to this office.

### ARTICLE V - COMMITTEES

Section 1 The President shall appoint the following standing committees: (1) Membership, (2) Project, (3) Program and Entertainment, (4) Budget and Finance, (5) Publicity, (6) Convention, (7) Study Group Advisory, and (8) By-Laws.

Section 2 Special Committees. In addition to standing committees, there shall be appointed by the President, such special committees as the President and/or the Board of Directors may deem necessary.

### ARTICLE VI - DUTIES OF COMMITTEES

Section 1 Membership. This committee shall promote activities designed to increase membership and shall perform such additional duties as specified by the Secretary in maintaining the records of membership.

Section 2 Projects. This committee shall devise and consider suitable and appropriate projects and shall devise ways and means whereby definite interpretation of the aims and objectives of the organization shall be given expression. It shall take cognizance of all matters of civic or similar nature and recommendations of the Project Committee shall constitute the basis for consideration of all projects of the organization.

Adoption of a project shall require a two-thirds vote of the entire Board of Directors.

Section 3 Program and Entertainment. This committee shall arrange and have charge of all programs for the regular meetings of the organization. They shall also have charge of all social functions of the organization, as may be directed by the Board of Directors.

Section 4 Budget and Finance Committee. This committee shall prepare a budget of the estimated income and expenses of the association for the year. In the month of May, each year, the Finance Committee shall cause a review of the books to be made by a licensed, Certified Public Accountant, and such statement shall be read to the organization at its annual meeting.

Section 5 Publicity. Publicity Committee shall be responsible for supplying notices concerning the organization meetings to the news media, and further, shall disseminate all interesting information furnished them by officers of the organization, chairmen of various committees. They shall also furnish the editor of the organization newsletter with news items for publication therein, promptly while it still has "news value".

Section 6 Convention. The Convention Committee shall have responsibility for all activities conducted during the annual Convention.

Section 7 Study Group Advisory. The Study Group Advisory Committee shall maintain official record of the activities of approved study groups. They shall furnish assistance and guidance to the study groups including, but not limited to, suggested topics for meetings, group projects, and research activities. They shall further, make newsworthy information and current listings of contact representatives available to the Publicity Committee.

Section 8 By-Laws. The By-Laws Committee shall review and make recommendations to the Board of Directors regarding needed or proposed amendments to the Constitution and or By-laws. This committee's activities will best reflect the changing needs of the organization.

### ARTICLE VII - ELECTION OF DIRECTORS

Section 1 (a) The Directors of the organization shall be elected by mail, prior to the annual meeting each year. (b) At the regular meeting six months prior to the annual meeting, the President shall appoint a Nominating Committee of at least three members. The chairman shall be the immediate past president, then an active member of the organization. Should the immediate past president be unable to chair this committee, the Board of Directors shall appoint a chairperson selected from the committee. (c) At the regular meeting three months prior to the annual meeting, the Nominating Committee shall present a report, giving the number of Directors to be elected and presenting one or more nominations for each vacancy, at which time additional nominations will be entertained from the floor. (d) The consent of all nominees must be obtained prior to his/her nomination.

Section 2 (a) At least 30 days prior to the annual meeting, a ballot containing all nominees for Board vacancies, will be mailed to the entire voting membership. This ballot must be returned to the National Cambridge Collectors, Inc. no later than 7 days prior to the annual meeting. (b) The results of this ballot shall be announced at a membership function prior to the annual meeting. (c) The nominees receiving the

largest number of votes so cast shall be declared elected for the term of office beginning at the close of business of the annual meeting.

Section 3 Election of Officers. Officers shall be elected as provided in Article V of the Constitution. (a) This shall occur at a special meeting of the newly established Board of Directors, at a time which shall not exceed 30 days after the annual meeting. (b) All nominees for office must have previously agreed to accept their nominations. (c) Officers shall assume duty immediately upon their election.

Section 4 The Board of Directors shall consist of 12 members elected from the roll of active voting members. The term of office shall be for 4 years.

To provide for continuity of operations the original Board of Directors shall serve for the following terms:

- 3 persons for 1 year March 1973 to May 1974
- 3 persons for 2 years March 1973 to May 1975
- 3 persons for 3 years March 1973 to July 1976
- 3 persons for 3 years March 1973 to July 1977

## ARTICLE VIII - MEMBERSHIP DUES

Section 1 Annual membership dues shall be as determined by the Board of Directors.

Section 2 Family Member. Each additional household member is eligible to become a voting member upon payment of prescribed dues per year.

Section 3 When payable. All dues shall be payable when billed by the Treasurer. No member shall be deemed in good standing who is in arrears more than 30 days in the payment of his dues.

## ARTICLE IX - RESOLUTIONS AND SUBSCRIPTIONS

Section 1 No resolution or motion to commit this organization on any matter shall be considered by the organization until it has been considered by the Board of Directors. Such resolution or motions, if offered at an organization meeting, shall be referred, without discussion, to the Board, which after having given consideration to the matter shall submit its recommendations to the organization. Having received the recommendations of the Board, the organization may then proceed to take such action as may deem proper to the majority.

Section 2 No assessments shall be permitted to be placed upon the membership of the organization, neither shall any person nor organization be permitted to appeal for funds for any purpose whatsoever before a regular meeting of the organization.

## ARTICLE X - TERMINATION OF MEMBERSHIP

Section 1 Resignation. Resignation of any member when delivered in writing to the President or Secretary shall become effective immediately upon its acceptance by the Board, providing all indebtedness of such member to the Club has been paid.

Section 2 Non-Payment of Dues. Any member owing dues or otherwise indebted to the organization for a period of 30 days from the date when same becomes due and payable may be suspended and deprived of all privileges of the organization. If he applies for reinstatement within sixty days from the date of such suspension and pays all amounts owing to said date, the Board of Directors may, in its discretion, reinstate the member to good standing, otherwise he shall stand dropped from the roll of members.

Section 3 Misconduct. Any member who by personal or business conduct violates the principles or ethics of the organization may be expelled from membership by the Board of Directors by a two-thirds vote of the entire Board, at a meeting called for that purpose, provided that said member shall have been given ten days notice in writing of such pending action together with a copy of the complaint against him, and shall be given an opportunity for a full and fair hearing.

## ARTICLE XI - AMENDMENT OF BY-LAWS

Section 1 These by-laws may be amended by a majority vote of the Active members in good standing present and voting at any regular meeting of the organization after recommendation by the Board of Directors, or by any twelve active members, provided written notice of such proposed amendments shall have been given to all active voting members at least ten days prior to the meeting.

No amendments or additions to these by-laws shall be made which are not in conformity with organization Constitution.

## ARTICLE XII - APPROVED STUDY GROUPS

Section 1 Application for Approved Status. Any three or more members in good standing may make written application to this organization for recognition as an approved study group. Such application shall be reviewed by the Study Group Advisory Committee and a report shall be made to this organization recommending disposition of the application. The application shall include an initial membership list, designated contact representative of the study group, and such other information deemed necessary for the official record.

Section 2 Name. The name of an approved study group shall be "Cambridge Collectors Study Group No. ". Study Groups shall also be encouraged to adopt an additional common name of their choice.

Section 3 Membership. All members of an approved study group must be members in good standing of this organization and shall have a sincere interest in the study and collecting of Cambridge glass. Study groups shall be limited to a maximum of twenty members. No additional membership requirements shall be made.

Section 4 Meetings. Approved Study Groups are encouraged to hold a minimum of eight study group meetings each year for the purpose of studying Cambridge glass or closely related subjects.

Section 5 Reports. The study group shall submit a monthly report to the Study Group Advisory Committee for the purpose of maintaining the official record of the activities of the study groups. The report shall include any changes in the membership or designated contact representative of the study group, a summary of activities and subjects discussed and other matters specified by the Study Group Advisory Committee.

Section 6 Authority. A study group shall have no authority to commit this organization on any matter.

Section 7 Termination of Approved Status. Termination of the approved status of a study group shall become effective upon acceptance, by the organization, of a recommendation of discontinuance made by the Study Group Advisory Committee. Such a recommendation shall be: (1) if requested in writing by the members of the study group, (2) for non-compliance with the rules and regulations of this organization, (3) due to inactivity for a period exceeding six months, or (4) due to conduct which violates the principles or ethics of this organization, provided that the contact representative shall have been given ten days notice in writing of such pending action together with a full statement of the reason for the recommendation, and shall have been given an opportunity for a full and fair hearing.

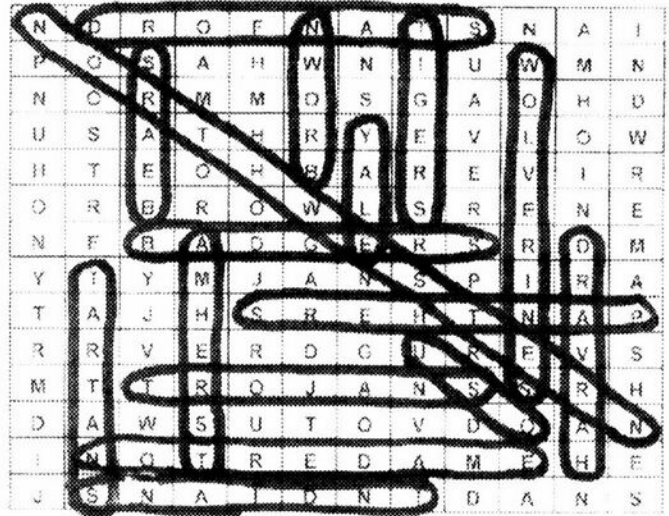
